**Comments: Incoming Transfers (Line C) does not balance with Total Out Going Transfers (Line J). The variance of 65 is attributed to transfers within the community that are not being tracked until the animals are adopted. Ending counts for 2006 will be adjusted for beginning counts for 2007 to reflect actual on hand and in foster care programs; animals will be tracked as soon as transferred for 2007.**
